2016 Annual Membership Meeting December 11, 2016

Vickie Robinson, Chairman, called to order the meeting of the Historic Carter House Society Inc. (HCHS) held at 30325 Carter Cemetery Road, Springfield, LA at 4:15 PM. Introduction of Officers

Vickie introduced the present officers of the Historic Carter House Society.

Membership Drive for 2017

Vickie will send out an email requesting 2016 members to renew their membership for 2017. Vickie will also email non-members explaining who the Historic Carter House Society is and what we do.

<u>The Financial Report</u> - Linda Simoneaux provided a copy of the Income Statement to attendees. Linda advised that the bank balance as of November 30, 2016 was \$17,491.46. Additional expenses and income for December was listed on the income sheet, which are not included in the November balance, and will bring our balance to \$17,649.77 after they are processed through the bank.

Carter House Restoration Projects

Vickie advised that the duct work, damaged by the flood, has been repaired and will be paid for by the CDD.

The AC/Heating unit that covers the Dining and Kitchen area no longer works. This unit was undersized for the area it covers. We are in the process of obtaining three bids to replace this unit. Two of the three bids have been received so far. We will proceed to have the unit replaced with the lowest bid after all bids are received.

Vickie voiced concerns with the slow progress on restoring the Pool House. The CDD has taken control of gutting and cleaning the pool house. Questions from the floor as to who owns the Pool House, who insures the pool house and was it covered for flood. Vickie advised that the Pool House is owned and insured by the CDD and they did not have flood insurance. The CDD is waiting to see how much money they will get from FEMA. Vickie advised that she also applied for a Public Assistance Grant for repairs.

Fundraising Plans for 2017

- 4. Susan said Springfield Fire Department has a facility for rental use. Suggested maybe a joint fundraiser with the Fire Department maybe a dance.
- 5. Annette suggested a bridal show and information was passed along about one that Shelley had planned a couple of years ago but attendance wasn't good. Consideration should be given to trying another and include brides. Participation at other bridal shows had been looked into but most of them were very expensive and not something we could afford.
